



Soon after the close of each Financial year, the society shall prepare in such form as may be prescribed.



20. iv) Out of the balance a dividend not exceeding 20% per annum on the account of the paid up share capital may be paid to the members for the period during which the share capital was held during the year.

24. All cash balance in excess of Rs. five thousand (A.5000) only shall be deposited in the District Co-operative Bank Ltd. or in another Bank approved by the Registrar, in default these of interest at 18% per annum shall be realised from the custodian and he shall be liable to be proceeded against under law.
